



## **PROMONTORY DOG PARK**

**Dog Park Hours: Sunrise to Sunset**

**NO ATTENDANT ON DUTY. This off leash Promontory Dog Park is self-supervised. Use this park at your own risk. You are responsible for damage or injury inflicted by your dog(s).**

**The Promontory Dog Park is not appropriate for and may not be safe for small children.**

### **ENTERING AND LEAVING PARK**

For your safety, please abide by these guidelines when entering and leaving the park:

- Do not open the outside gate if the inside gate is open. One family of dogs at a time in the inside enclosure (between the double gates) at a time.
- Remove dog's leash inside the double gated area. Make sure the gate is closed after entering the park.
- Do NOT leave a leash on dogs in off-leash area of the park. This can actually cause altercation as a dog may feel restricted in its ability to protect itself. Also, dogs may feel more protective of their owners when leashed. DO carry your leash into the area in case you need to quickly remove your dog.
- When new dogs enter the facility it can get really congested at the gate area, so move your dogs away, giving the new dogs a chance to get acclimated.

### **Warning About Small Children in the Dog Park**

- Not all dogs are socialized with small children
- A child running may be seen as prey.
- Some herding dogs may attempt to herd your child. The dog may also become territorial over your child which can cause a fight that could injure or scare your child.
- When dogs are playing, they naturally mouth, mount and may body slam. A dog may mistake your child for another playmate.
- The dog park can be quite overwhelming to small children.
- A dog fight may occur which could put your child in a dangerous situation.

**IMPORTANT ANIMAL CONTROL INFORMATION:** In any case of a pet running at large or off-leash outside of the Promontory Dog Park and/or being a nuisance or hazard to persons or wildlife (i.e. attacks, acting viciously, causing unsanitary effects on the environment, making continuous noise, or being a danger to public health, safety and welfare), all Promontory residents and/or persons on Promontory property should independently call Summit County Animal Control at 435-615-3985. Any person having knowledge of a person or animal being bitten (causing a puncture, tear, or abrasion of the skin) by another animal is required by law to immediately contact Summit County Animal Control at 435-615-3985.



## PROMONTORY DOG PARK RULES

1. Dogs must be leashed when entering and exiting the Promontory Dog Park. Please observe on and off leash areas of the park.
2. No children under the age of 12 permitted unless accompanied by an adult
3. No puppies younger than 4 months in the off leash areas.
4. NO FOOD or dog toys allowed inside the Promontory Dog Park.
5. Dogs must be current on all vaccinations. No dog with a contagious condition or illness allowed inside the park.
6. Dogs must have a current dog license and should wear an owner ID tag. Proof of current rabies vaccination and license is required upon request by police or animal control officer. Tags may serve as proof. Dog license information: Summit County Animal Control (435) 615-3985
7. Choke, prong (pinch) and spike collars are strictly prohibited inside the dog park.
8. No aggressive dogs allowed in the Promontory Dog Park. Dogs must be removed at the first sign of aggression.
9. No female dogs in heat allowed in the Promontory Dog Park.
10. Dog owners must be in the park and within view of their dogs at all times and keep their leash in hand at all times for handling and removal in case of emergency.
11. All off-leash dogs must be under voice control of their owners. If you cannot control your dog off-leash, remove your dog from off leash area.
12. Do not let your dog dig holes or damage property. Fill any holes your dog digs.
13. ALWAYS SCOOP YOUR DOG'S POOP! Owner must clean up dog's feces. Bags and receptacles are provided; please seal waste before disposing. Also, please help with "Orphan Poop". Continued operation of this type of public amenity will depend on our control of this issue!
14. Failure to abide by the park rules may result in loss of privileges or citation.
